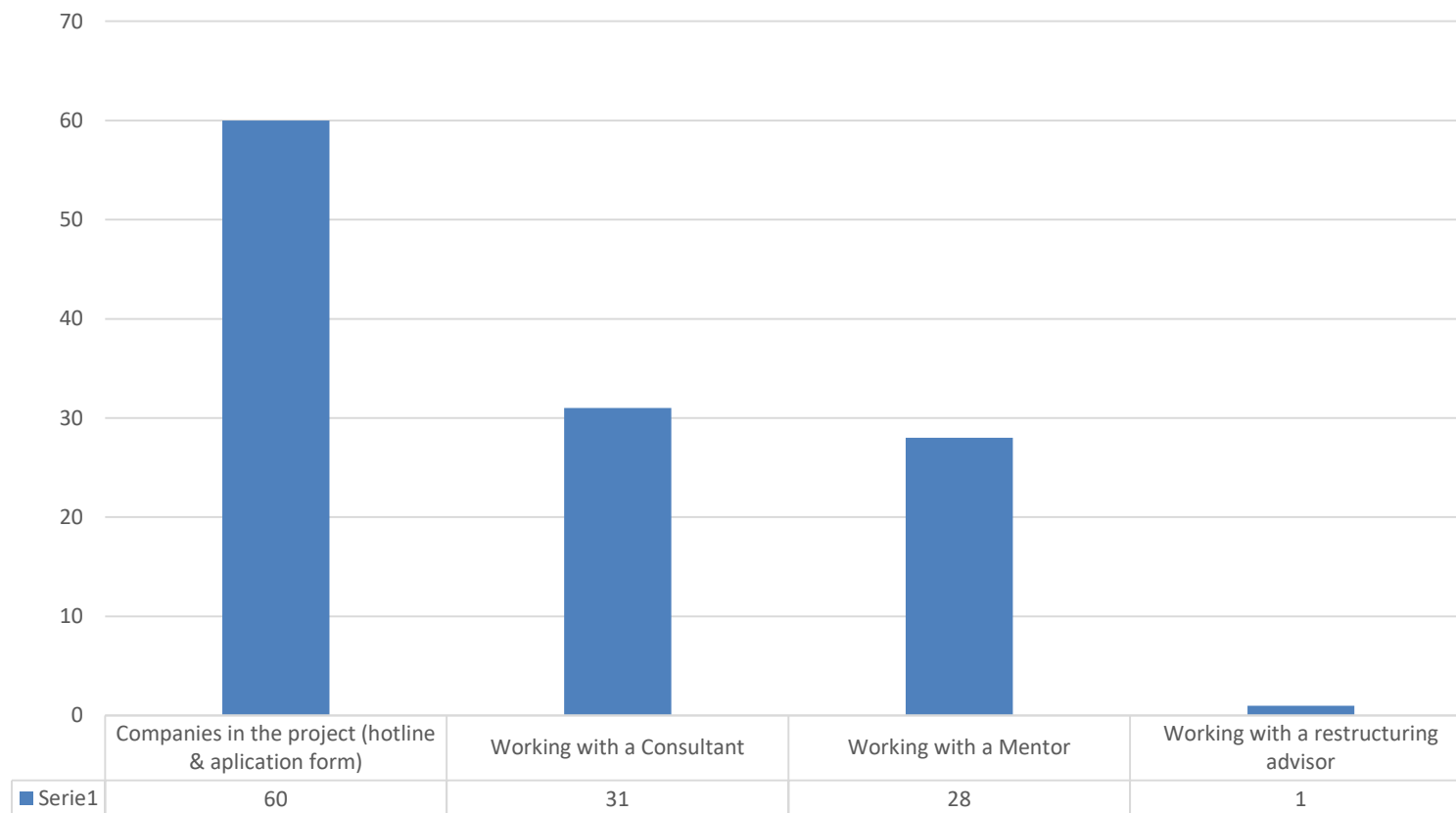

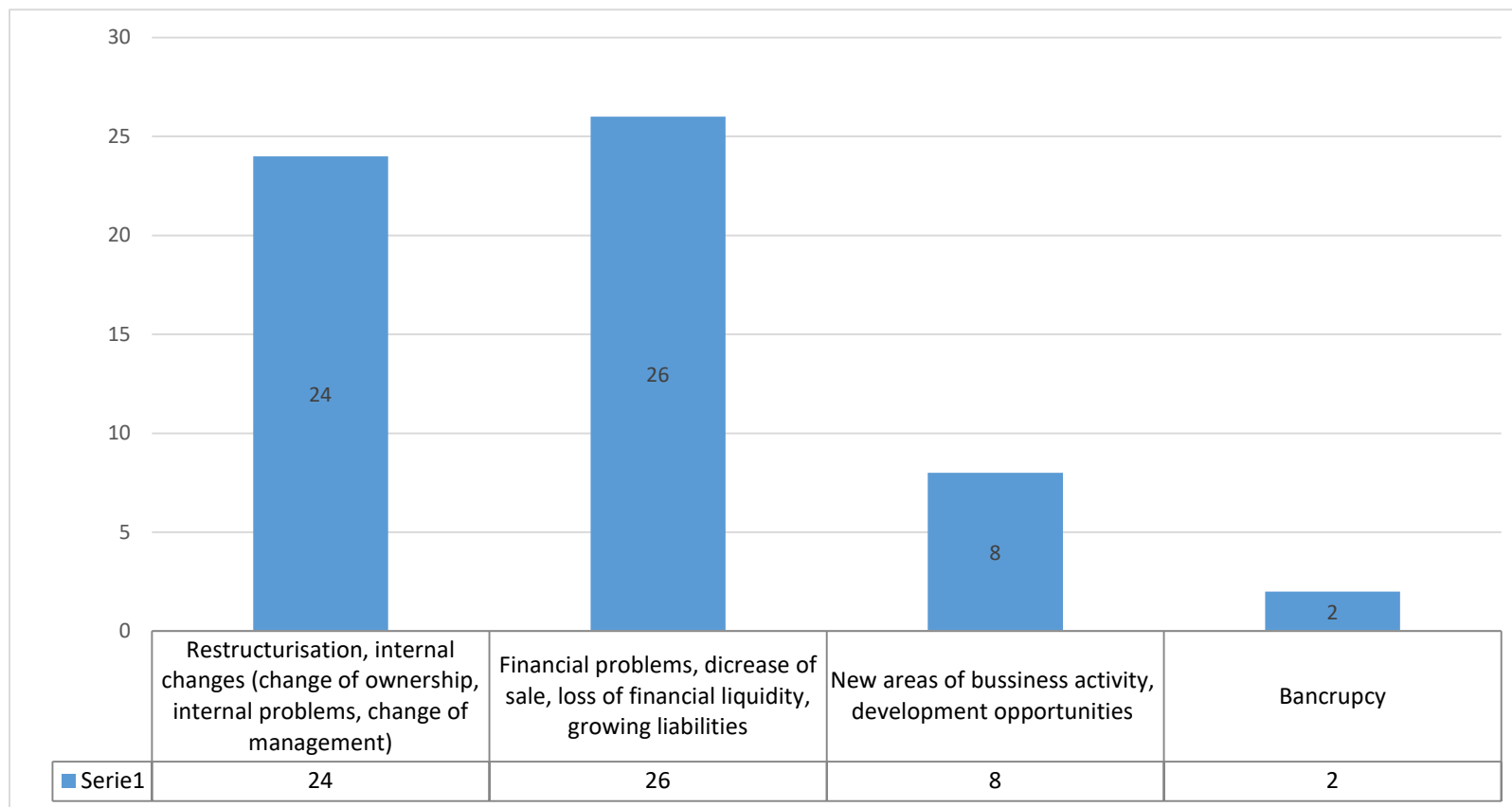
Sectors of the companies in EW Poland

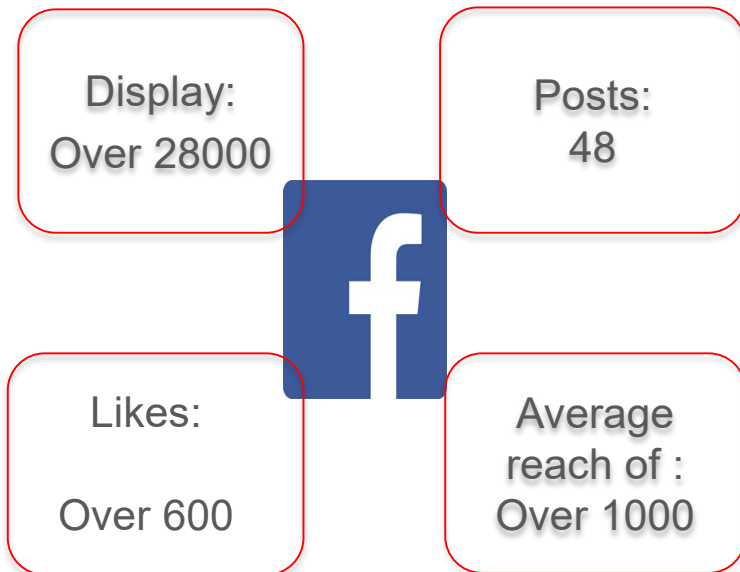

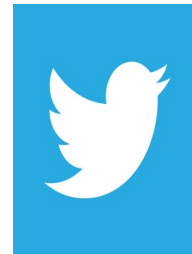

- Another 12 waiting for training in March 2018

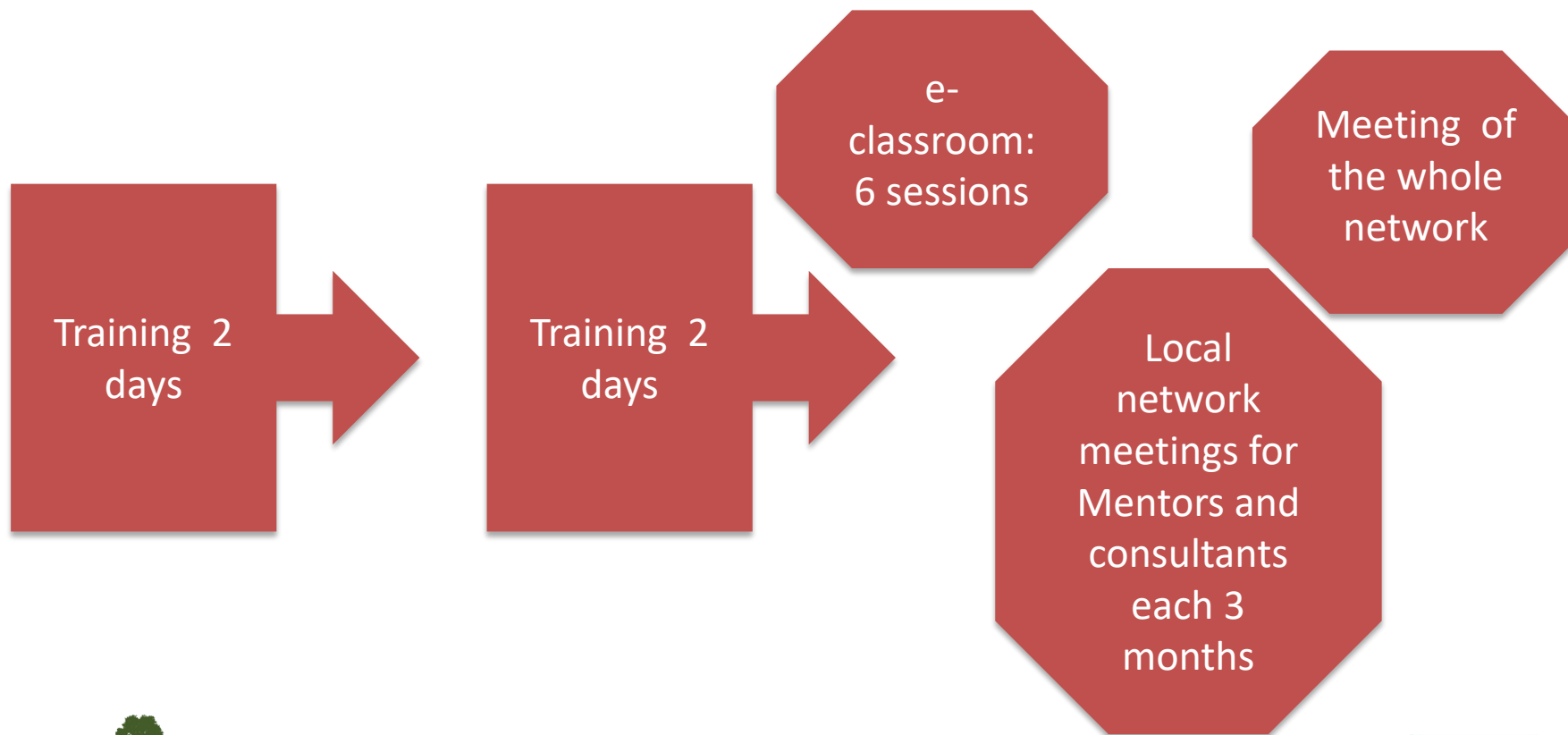

The Mentors' training and networking processes

Training goals:

- To familiarise them with the entrepreneurs support process in the EW project
- To know the roles, tasks and tools at a Mentor's disposal
- To accept the code of ethics of the Early Warning
- To explain the mentoring in line with the GROW methodology (coaching approach)
- To develop the communication adjustment skills depending on the partner in the communication process according to the DiscClassic
- To know how to contract and set targets with Mentee
